Upcoming Training: Migrants' Human Rights

We are thrilled to announce an exceptional line-up of speakers for our September 23rd training on the human rights of migrants. These experts will review current, pressing challenges around migrants' legal representation, migrant workers' rights, detention and

conviction of former Bosnian Serb leader Radovan Karadzic on July 28. A former attorney with the International Criminal Tribunal for the former Yugoslavia (ICTY) and a forensic investigator for international criminal tribunals discussed the evidence and legal basis of Karadzic's responsibility for the genocide in Srebrenica.

Forced Sterilization Brief

In May, IJRC submitted an *amicus curiae* brief to the Inter-American Court of Human Rights, together with the International Human Rights Clinic at Santa Clara University, in the case of *I.V. v. Bolivia*. While in the hospital to give birth, I.V. was permanently sterilized without her consent. We urged the Court to apply a holistic analysis in cases of forced sterilization, to expand on its analysis of the right to dignity and find a violation of that right in this case, and to order Bolivia to ensure medical professionals receive proper training on informed consent and the human rights of women. We eagerly await the Court's ruling.

Human Rights News

At the United Nations, the Human Rights Council made the long-awaited decision to establish an expert focused on violence and discrimination against LGBT persons.

The UN Working Group on Arbitrary Detention concluded that China is <u>wrongfully detaining</u> an American accused of spying.

Australia must not exclude <u>deaf people</u> from serving on juries, the UN Committee on the Rights of Persons with Disabilities recently determined.

The World Health Organization issued new guidelines on the rights-based treatment of <u>FGM survivors</u>.

During the first World Humanitarian Summit, participants adopted a <u>Charter on the Inclusion of Persons with Disabilities in Humanitarian Action.</u>

The Inter-American Commission on Human Rights announced a severe <u>financial crisis</u> immediately impacting its work.

Meet the Team

The Inter-American Court of Human Rights will hear a case involving the "false positives" killings phenomenon in Colombia.

In new decisions, the European Court of Human Rights addressed the rights of <u>LGBT migrants</u>, and held that psychiatric treatment is necessary to give prisoners serving <u>life sentences</u> a chance of release.

The European Committee of Social Rights found Ireland's accommodation of <u>travellers</u> to be inadequate.

The African Commission on Human and Peoples' Rights held that Botswana's use of <a href="https://hanging.new.google.com/hanging.com/hangin

The son of former Libyan ruler Muammar <u>Gaddafi</u> must not be held in secret detention, the African Court on Human and Peoples' Rights held.

The East African Court of Justice directed the East African Community to investigate Tanzania's <u>expulsion</u> of migrants.

Crises in <u>Venezuela</u>, <u>South Sudan</u>, <u>Syria</u>, <u>Turkey</u>, and <u>Ukraine</u>, as well as <u>gun violence</u> in the United States, drew the condemnation of human rights bodies.

In Argentina, a court issued the first conviction of a former head of state in connection with <u>Operation</u> <u>Condor</u>.

The International Law Commission adopted new articles toward a draft treaty on <u>crimes against humanity</u>.

Former Bosnian Serb leader <u>Radovan Karadzic</u>, convicted in March for the genocide in Srebrenica, has announced he will appeal.

A new study from the International Criminal Tribunal for the former Yugoslavia examines the long-term impact of testifying on <u>victim-witnesses</u>.
